It distributed over 17 million pounds of food to over 145 agencies on the front-line of hunger relief from Tequesta to Boca Raton and from Belle Glade and Pahokee to the Coast. The Lois' Food4Kids program served weekend food packs to upwards of 4,000 children at 64 partner agencies throughout the year. The Benefits Outreach program helped almost 7,000 individuals receive over \$6.5 million of federal food benefit assistance and had over 2,000 participants from Marjorie S. Fisher Nutrition Driven, a nutrition education program in partnership with the Palm Beach County Extension/University of Florida Institute for Food and Agriculture
