Resource Center: 211 HelpLine, a crisis hotline and community helpline, operates 24 hours a day, 7 days a week, 365 days a year. In our fiscal year July 2020- June 2021, 211's highly trained Resource Center Specialists responded to 121,275 requests for help via phone, text, email, and online chat, and an additional 24,391 self-service database inquiries, for a total utilization of 145,666 requests for help from Palm Beach, Martin, St. Lucie, Indian River and Okeechobee County residents. Of these, 45,353 were related to mental health and addiction issues, including 3,883 suicide-related request for help requiring intensive support and life-saving assistance. 4b (Code:) (Expenses \$ 187,541. including grants of \$ 464.) (Revenue \$) Elder Crisis Outreach: 211's Elder Crisis Outreach (ECO) program is devoted to serving vulnerable elders (aged 60 and up) in Palm Beach County who are at an increased risk of experiencing a crisis event. These elders may not have the physical strength, the financial resources or the family or caregiver support to deal with a crisis alone and are unsure of where to turn for appropriate sources of assistance. 4c (Code:) (Expenses \$ 453,854. including grants of \$) (Revenue \$) Help Me Grow: The Help Me Grow (HMG) program housed at 211 Palm Beach/Treasure Coast was launched in 2014 as part of a National and Statewide initiative with 211 serving as the central access point. The program is designed to identify children (aged 0-8) residing within Palm Beach County and the Treasure Coast who are at-risk for developmental or behavioral concerns and connect their families with community-based programs for health, developmental and behavioral services. 211 provides empathetic guidance and support to individuals and families in distress or in need of information about health and human services programs. This free and confidential telephone based assistance is available 24 hours a day, 365 days a year to anyone who dials 2-1-1. The agency also provides daily telephone reassurance calls to homebound elders; to elders in distress; to families with special needs children from birth to age 22; and to families of children 0-8 who are at-risk for behavioral or developmental disabilities. We have spearheaded successful partnership campaigns with Leadership Palm Beach County to promote texting services to youth, worked with Tri-Rail to help combat suicide by train, and being the central access point for the treatment of opioid addiction for individuals without insurance. 211 leadership and staff are dedicated to being here for our local residents in times of crisis and need, and, unfortunately, we are needed now more than ever.

Form 990, Part III, Line 4a, Program Service Accomplishments:

Additionally, 129,396 referrals, requiring assessment of needs along with supportive guidance, were made for 147,378 expressed community needs from those who we serve. This program has been in operation since 1971 and is nationally accredited by the Alliance for information and Referral Systems (AIRS) and the American Association of Suicidology (AAS) to provide information and referral services along with crisis intervention and suicide prevention services. Further, all services are

free, confidential and services are available via phone, chat, text and email in addition to the online database on our website. 211 has been here throughout the ongoing COVID-19 pandemic to provide emotional support, information, and resources to those in our community who are struggling with the lingering impacts of this public health crisis. Our community depends on being able to turn to the 211 HelpLine, 24 hours a day, 7 days a week, especially during times of disaster, and our Resource Center Specialists are skilled at providing crisis de-escalation techniques and community resources that help stabilize and resolve the crisis situations members of our community are facing, very often saving lives.

Form 990, Part III, Line 4b, Program Service Accomplishments:

This program has been in operation since 1985, providing skilled advocacy and care coordination services by way of our experienced ECO Advocates who will visit the elder should an in-home assessment be needed (when it is safe to do so) and provide them with short-term assistance in resolving their unique and often complex issues by connecting them with appropriate services to meet their basic needs. This program has been especially valuable to Palm Beach County seniors during the COVID-19 pandemic, when more seniors than ever before were at-risk of battling with a crisis situation due to the increased threat that the virus presented for this population. In our previous fiscal year from July 2020- June 30, 2021, a total of 848 Palm Beach County elders were served by ECO.

Our HMG Care Coordinators are knowledgeable about the local health and

human services network and skilled at providing these completely free screenings to identify potential developmental concerns to help provide early intervention and improved outcomes for these children with challenges. In our previous fiscal year from July 2020- June 2021, HMG provided support, referrals and information to 750 families with a total of 823 children and completed 1,965 screenings throughout Palm Beach County and the Treasure Coast.

Form 990, Part III, Line 4d, Other Program Services:

Sunshine Telephone Reassurance: 211's Sunshine Telephone Reassurance Program is a primarily volunteer-run program that was established in 1973. This program provides a once daily scheduled call to elders (aged 60 and up) and other homebound individuals residing in Palm Beach, St. Lucie, Okeechobee, Indian River and Martin counties to check on their wellbeing and bring human connection into their day. This program also save lives every year by providing emergency intervention in the event that the Sunshine client does not answer their scheduled phone call after multiple attempts. In our previous fiscal year from July 2020- June 2021, 731 isolated, lonely elders or disabled individuals received daily telephone reassurance calls through the contribution of our 17 volunteers, equating to approximately 1,089 hours of volunteer service. During this year, 164 incidents of potential risk for Sunshine clients were identified and required some follow-up to ensure a client's safety.

Special Needs Helpline: 211's Special Needs HelpLine serves as the centralized access point for families with children who have special needs (aged birth to 22 years) in Palm Beach County to receive support,

guidance, care coordination services, and advocacy along with information on a wide range of additional support services. These services can include medical, dental, specialized therapy services, support groups, child care, respite care and other services families with special needs children may require. In our previous fiscal year from July 2020- June 2021, the Special Needs Helpline served 428 families of children with disabilities.

Expenses \$ 211,270. including grants of \$ 12,328. Revenue \$ 5,500.

MYFLVET: The MYFLVET program at 211 Palm Beach/Treasure Coast connects Florida Veterans to mental health, substance abuse, and other relevant services by way of a peer Veteran Advocate who has behavioral health experience and who can effectively utilize the existing 211 infrastructure to assist in resolving or stabilizing the crisis situations that Veterans are at a heightened risk of experiencing. This program is specifically designed to provide an easily accessible entry point for finding critical Veteran-specific information and resources and to serve as a primary source of information and referral for returning Veterans who are struggling to return to civilian life. In our previous fiscal year from July 2020 to June 2021, 352 veterans in Palm Beach County and the Treasure Coast were linked to care coordination services and advocacy from one of 211's Veteran Advocates. Expenses \$ 108,373. including grants of \$ 0. Revenue \$ 0.
