

Highly trained specialists responded to 100,372 requests for help, and an additional 14,942 self-service database inquiries, for a total utilization of 115,314 requests for help from Palm Beach, Martin, St. Lucie, Indian River and Okeechobee County residents during the fiscal year ending June 30, 2019. Of these, 40,629 were related to mental health and addiction issues, including suicide, requiring intensive support and life-saving assistance. Additionally, 103,534 referrals, requiring assessment of needs along with supportive guidance, were made to 119,125 community needs. This program has been in operation since 1971 and is nationally accredited. Further, these services are now available via chat, text and email in addition to

4b (Code: ) (Expenses \$ 191,667. including grants of \$ 1,892. ) (Revenue \$ ) Elder Crisis Outreach: This program is devoted to serving vulnerable elders in Palm Beach County who may not have the physical strength, the financial resources or the family or caregiver support to deal with a crisis alone. This program has been operating since 1985, providing skilled staff who will visit the elder should an in-home assessment be needed and provide them with short term assistance in resolving their issues by connecting them with appropriate services to meet their needs. In the fiscal year ending June 30, 2019, a total of 960 elders were served.

4c (Code: ) (Expenses \$ 415,728. including grants of \$ 1,482. ) (Revenue \$ ) Help Me Grow: The Help Me Grow program was started in 2014 at 211 Palm Beach/Treasure Coast. The program is a National and State initiative. The program is designed to identify children at-risk for developmental or behavioral concerns and connect them with community-based programs for health, developmental and behavioral services. Help Me Grow provided support, referrals and information to 1320 families with a total of 1454 children and completed 1483 screenings in the fiscal year ending June 30, 2019.

The agency also provides daily telephone reassurance calls to homebound elders; to elders in distress; to families with special needs children from birth to age 22; and to families of children 0-8 who are at-risk for behavioral or developmental disabilities. We have spearheaded successful partnership campaigns with Leadership Palm Beach County to promote texting services to youth, worked with Tri-Rail to help combat suicide by train, and being the central access point for the treatment of opioid addiction for individuals without insurance. 211 leadership and staff are dedicated to being here for our local residents in times of crisis and need, and, unfortunately, we are needed now more than ever.

2019, 629 isolated elders or disabled individuals received daily telephone reassurance calls through the contribution of our 20 volunteers, equating to approximately 5,945 hours of volunteer service. Further during the year, 355 incidents of potential risk were identified through the Sunshine program that required some follow-up to ensure a client's safety.

Special Needs Helpline: This program serves as the centralized access point for families with special needs children Birth - 22 years. Support, guidance and advocacy is provided along with information on a wide range of services: medical, dental, specialized therapy services, support groups, child care, respite care and other services families with special needs children might require. In the fiscal year ending June 30, 2019, 465 families of children with disabilities were served.

MYFLVET: This program connects Florida military Veterans to mental health, substance abuse, and other relevant services using existing 211 infrastructure and Veterans with lived behavioral health experience. The program is specifically designed to provide an easily accessible entry point for finding Veteran-critical information and to serve as a primary source of information and referral for returning Veterans. Sixty-nine (69) veterans were linked to care coordination services from the program's inception of March 2019 to June 30, 2019. Expenses \$ 228,896. including grants of \$ 16,928. Revenue \$ 3,700.
