Vita Nova is the county's lead provider for Post-Secondary Education & Supports (PESS), and Aftercare services for youth ages 18-23 from the State Foster Care system, and served 130 youth. Through PESS, Vita Nova provides supports to youth that are enrolled in Post Secondary programs to assist them to be academically successful and to be able to be self-sufficient.

4b (Code:) (Expenses \$ 563,095. including grants of \$) (Revenue \$ 14,930.) Vita Nova Village

Vita Nova Village provides housing for young adults ages 18-25 who are at-risk of homelessness. The program is designed to assist young adults to learn to live independently in five core areas: financial literacy, social/emotional health, vocational training, educational planning and health & wellness.

Vita Nova Village is a supportive living environment for youth who are looking for help with daily living skills, but do not have a home to learn them. Services provided include coordination with employment, healthcare, education (high school, college and vocational), wellness,

Vita Nova operates the only drop-in center for youth at-risk of homelessness in the county, called the Spot. Located in West Palm Beach the Spot is a safe and non-judgmental center for youth ages 18-25 years old and served 213 youth.

The Spot team has access to many of the resources required to move a youth quickly from homeless to housed in a day. This dynamic team consists of an Intake Specialist providing first contact and assessment, a Therapist to address overall wellness, Health Care Specialist helping youth find affordable health care insurance and connections to health care professionals, Employment Case Managers to
