

(PCC), a member of Community Partners, is a not-for-profit organization providing the highest quality behavioral health therapy and counseling services to children and families in Palm Beach County, changing life outcomes for the youth in high-risk communities where there are concentrated pockets of poverty. Since our beginning in 1979, PCC has grown to be widely recognized as the county's leading agency of caring experts helping our most vulnerable children - victims of trauma, abuse and neglect, among other childhood developmental social, emotional and psychiatric disorders. As proof of its dedication to expert services, the Parent-Child Center was accredited by the Council on Accreditation (COA) in 2006 and received its most recent national re-accreditation from COA in 2016.
