At Parent-Child Center, we believe in changing the odds for children and families facing adversity. We specialize in treatment for trauma, depression, attention-deficit, anxiety and other disorders that can impact the development of children and teens. The clients served at the Parent-Child Center face numerous obstacles related to multiple risk factors such as poverty, substance abuse, physical abuse, and mental illness. In 2018, there were 3,789 children and families in Palm Beach County who benefited from our services. Our objectives are met through six distinct programs providing essential mental health services for children and families that are individualized, strengths-based, and trauma informed. In 2018, Parent-Child Center continued implementation of our innovative training program. This training program ensures that all service providers are equipped to partner with families on their goals. Current programs include:

Intake and Assessment Services

There were approximately 3000 referrals received during the 2017-18 year with an average of 250 per month. Intake was able to successfully complete assessments on 65% of those referrals per month.

Outpatient Child and Family Mental Health Services

The Outpatient therapy services department provided mental health services to 1,270 children and 502 adults this year. Of the children

served, we provided individual and family therapy through our Two Generational approach, with over 55% of our child client receiving family therapy. Our department also celebrated three therapists obtaining licensure status. We continued to hire and provide training for over 20 therapists and aim to hire more in hopes to serve more children and families in the upcoming year.

School based programing (targeted case management and therapy) has increased access to mental health treatment to students and their families. Families who held back from treatment due multiple barriers, time, money, access, stigma, are now given the opportunity to engage in services in a convenient, safe, and cost-effective place. The school receives support from the assigned mental health professional during incidents like crisis, staffing, and classroom behavior concerns. The county has entrusted CP with 2 additional schools in the Belle Glade area to continue the same model from the original 3 schools. These families have been able to bypass the waitlists in the community for providers and speak to a provider within days of referral.

Triple P Parenting (A parent skill training program)

There were 1159 individual parents/primary caregivers who participated in one or more levels of Triple P in 2018. 79.6% were female caregivers & 20.4% were male caregivers with 78% being English speaking, 18% Spanish speaking and 4% Creole speaking. Of the 1159 families who participated in Triple P 959 of the families engaged in Standard Triple P serving families with children Birth to 11 years old and 200 of the families engaged in Teen Triple P serving families with children 11 17 years old. Parents were significantly more likely to report improved parental competence. Parents were significantly more likely to report lower levels of depression, anxiety and stress, with most gains in

stress reduction. Parents more likely to report that behavioral issues were less frequent and less of a problem and pro-social behavior were more frequent in their children. Overall there was a reported 98.1% high level of satisfaction with the program in all areas assessed; the higher the level of Triple P, the more satisfaction reported. There were 265 90-minute seminars offered in 2018 in a combination of English, Spanish, and Creole. These seminars were delivered throughout the community. The entire Triple P and Teen Triple P staff attended a master's Level Triple P training in 2018 given by Professor Matt Sanders the founder of Triple P.

Targeted Case Management (Identification of primary basic needs and linkage to community resources for families receiving services from PCC)

Targeted Case Management department had an 85% successful discharge rate for all clients. 95% of clients gained health insurance during services, 84% of clients were successful in having a primary care physician at discharge.

Crossroads Community Care (A program for children and young adults with a serious mental health issue)

One of the therapists is licensed, the other is licensed eligible. There has been a significant decrease in case turnover with the current team we have, which means they are able to engage the families appropriately no matter the extraneous circumstances the clients are facing. They work as a team between a therapist and targeted case management to wrap the client with services for a better outcome. The goal is to decrease Baker acts, provide knowledge of their diagnosis

and treatment, and assist the families in connecting them to services in the community in order to maintain successes after discharge.

Trauma Care (Provision of trauma-trained therapist for children who have been removed from their home due to abuse or neglect.)

The licensed therapists were provided on call services totaling 2152 hours, which included crisis support to 216 children entering Palm Beach County's licensed foster and group home care during the 2017-18 year. 94% of the children removed were seen within 48 hours, which was vital in helping mitigate the effect of the trauma from the removal episode.

From the extensive offering above, our programs provide tremendous impact across the entire geographic area of Palm Beach County, including the far-western communities of Belle Glade and Pahokee. Our therapists are community-based, meaning they see clients and their families in their homes, schools, and community centers. Our hub for services resides at our offices in Riviera Beach, serving the most concentrated population of vulnerable families.

During 2018, HPI entered into various transactions with related parties. Each of these parties is related through common officers and/or directors.

Parent-Child Center, Inc.

HPI and PCC share expenses for management and support services. Employees may work for one of the two organizations but provide services to both. As such, each organization reimburses the other for its proportionate share of resources used. During the year ended September 30, 2018, the net effect of these shared resources was a payment by PCC to HPI of \$517,600. Approximately \$988,000 was due from PCC at year end. Mortgage receivable from PCC for the Village for Change program, at an interest rate of 4.00% per annum, requiring monthly payments of principal and interest totaling \$1,691, collateralized by the property. The mortgage balance as of September 30, 2018 is \$45,362 and matures January 7, 2021.
