Vita Nova Housing

Vita Nova provides comprehensive housing and supportive services dedicated to empowering youth who are experiencing homelessness or those at risk of homelessness to achieve long-term independence and self-sufficiency. Each housing program focuses on five core areas of youth development: financial literacy, social and emotional well-being, vocational development, educational planning, and health and wellness.

Participants are paired with dedicated Housing Case Managers who provide individualized support, advocacy, and guidance throughout their journey. Youth receive hands-on instruction in essential life skills,

The Spot Drop-In Center

Vita Nova's the Spot is the only drop-in center in Palm Beach County dedicated to serving youth experiencing homelessness or at risk of homelessness. Located in West Palm Beach, The Spot provides a safe, welcoming, and non-judgmental environment for young adults ages 18-25, offering immediate access to essential resources, supportive services, and connections that help youth transition from homelessness to safe and stable housing.

The Spot team provides comprehensive, youth-centered support tailored to meet each youth's unique needs. A team of Intake and Outreach Peer

Vita Nova Independent Living Services (VNILS)

Vita Nova is the county's main provider for young adults from the foster care system, choosing Post-Secondary Education Supports and Services (PESS) and Aftercare Services. Young adults in the PESS program receive assistance with enrolling, maintaining, and completing their post-secondary education, including certification for a trade. This program also assists young adults with financial literacy, housing, and other support to help them complete their education. Young adults enrolled in Aftercare Services receive support from Vita Nova in the areas of housing, mental health, wellness, tutoring, substance abuse, counseling, and financial assistance. Youth participating in Vita Nova Housing programs develop essential financial literacy skills that empower them to manage their finances confidently, make informed decisions, and build a foundation for long-term financial stability.

Each resident receives comprehensive life-skills training designed to support success in employment, education, housing stability, health, and overall well-being. Through individualized support and skill development, youth are equipped with the tools needed to navigate adulthood and achieve their personal goals.

The Vita Nova Housing Team continues to serve as a source of hope and opportunity, providing more than housing by delivering the guidance, resources, and supportive services young people need to build a stable, independent, and self-sufficient future.

Support Specialists serve as the initial point of contact, leveraging knowledge gained from their own lived experiences to connect with youth in a meaningful and nonjudgmental manner, conduct assessments, identify appropriate services and resources, and make necessary referrals. The Spot team also includes a Youth Engagement & Community Resource Officer who assists youth in accessing essential resources and remaining actively engaged in services; Career Coaches and a Securing Our Future Initiative (SOFI) Case Manager who connect youth to employment opportunities, life-skills development, educational supports, and vocational training opportunities; a Health Care Specialist, who assists youth with accessing affordable health insurance, healthcare providers, and medical resources; and a Licensed Clinical Therapist who supports youth's emotional wellness and mental health needs.

The Spot offers a wide range of supportive amenities designed to address immediate needs while promoting long-term stability and independence. The center features a computer lab, shower facilities, music therapy room, laundry facilities, clothing closet, kitchen, and food pantry stocked with shelf-stable foods, fresh produce, meats, and essential health and hygiene items. The Spot features a computer lab, shower, music therapy room, laundry services, clothing closet, kitchen, and food pantry with shelf stable foods and fresh produce and meats, hygiene, and health essentials. Vita Nova's robust network of community partners also provides youth with access to additional on-site resources, including a GED Center and various health and wellness services, such primary and psychiatric care, STI testing, and prevention education.

The Sleep Spot is an innovative new pilot program designed to increase stability and reduce exposure to trauma by providing youth access to immediate, short-term emergency beds while awaiting placement in shelter, transitional housing, or other more permanent housing solutions.

Through its comprehensive services and dedicated team, the Spot serves as a critical resource hub, providing young adults with the support, opportunities, and tools needed to overcome barriers, access housing,
