GROUNDING IN BRAIN SCIENCE AND EARLY RELATIONAL HEALTH, THIS PROGRAM PROVIDES BEST-PRACTICE, EVIDENCE-BASED INTERVENTIONS DURING THE CRITICAL PRENATAL-TO-AGE-SIX DEVELOPMENTAL WINDOW.

IN ADDITION TO CLINICAL SERVICES, CFCC OFFERS SPECIALIZED TRAINING AND CONSULTATION TO BUILD THE SKILLS OF PROFESSIONALS WORKING WITH INFANTS, YOUNG CHILDREN, AND FAMILIES. SERVICES ALSO INCLUDE COUNSELING FOR PREGNANT WOMEN AND NEW MOTHERS EXPERIENCING STRESS, TRAUMA, OR PERINATAL MENTAL HEALTH CHALLENGES.
