**Access to Care & Education**  
Through outreach, prenatal screening, perinatal care coordination and education programs, HMHB is a leader in maternal health support for women across Palm Beach County. Within the Healthy Beginnings system of care funded by Children's Services Council of Palm Beach County, our access to care work is designed to screen, assess, refer and educate any pregnant woman who resides in our community. In FY25, 1,495 women were connected through outreach efforts, 11,831 prenatal referrals received, 675 trainings and visits to obstetrics providers, 2,978 prenatal clients completed an intake, 232 postpartum moms linked with primary care providers and 1,333 participants attended a maternal and infant health education class.

**CenteringPregnancy**  
A national evidence-based group prenatal care model focuses on health assessment, education and social support. Studies show that Centering moms are actively engaged in their own healthcare, better prepared for labor and delivery and have lower rates of preterm birth. Last year, CenteringPregnancy moms had better birth outcomes than both the county and state average. In FY25, we served 808 women in CenteringPregnancy.

**Basics4Babies Emergency Pantry for Infants**  
This remains the only infant focused pantry in Palm Beach County providing infant essentials to families in need since our inception. For nearly ten years, infant hunger has become a priority for our pantry where we distribute formula, baby food and diapers to those facing financial hardship. In FY25, 11,071 children ages 0-3 served with 334,756 diapers, 3,349 containers of formula and 5,012 infant food packs.

Corporate volunteer groups and individual volunteers are engaged in the Basics4Babies Emergency Pantry for Infants with additional volunteers involved as mentors for teen mothers. Doulas in training are matched with HMHB clients of the same cultural identity as part of the certification, providing prenatal through postpartum doula support, all while building a workforce of doulas in Palm Beach County. In FY25, 31 doulas trained, 98 clients culturally matched with a doula in training, 49 total babies born with doula support; of these, 42 babies born 5.5 pounds or greater, 38 born greater than 37 weeks gestation and 39 clients improved postpartum outcomes.

Caps & Cribs is a mentoring program for teen moms. Utilizing the elements of effective practice to educate, engage and empower teens who are pregnant or parenting, this program provides one-on-one mentoring focused on high school graduation, career goals development and life skills to support growth as young mothers. In FY25, 72 teens received case management, 66 teen moms matched with a mentor and 24 new mentors trained.  
 Expenses \$ 177,462. including grants of \$ 906. Revenue \$ 0.

Circle of Moms is a maternal wellness program focused on addressing maternal mental health through peer support groups utilizing evidence-based curriculum and training for health professionals. This program addresses the 1 in 5 women who experience a perinatal mood or anxiety disorder. In FY25, 804 women served through peer support groups, 789 pregnancy and postpartum women improved their mental health and 687 health professionals trained in perinatal mood and anxiety disorders.
