The Foster Children's Project - The Children Advocacy supports children from birth to age 12, along with their siblings, who are in the licensed custody of the State of Florida. Once appointed by the Juvenile Court, the Project's attorneys advocate for these children in all court and administrative proceedings to protect them from abuse and neglect. They also work to ensure that the children achieve permanent placement with either their biological or adoptive parents within a 12-month period. In the fiscal year 2024-2025, the attorneys represented 437 clients in foster care.

4b (Code:) (Expenses \$ 1,971,619. including grants of \$ 12,430.) (Revenue \$)

The Fair Housing Project - The Individual Rights Advocacy offers community outreach, education, advocacy, and enforcement activities related to fair housing laws. Its goal is to ensure that individuals in Palm Beach, Martin, Okeechobee, Hendry, and St. Lucie counties are not denied housing based on race, sex, color, religion, national origin, handicap, familial status, sexual orientation, age, marital status, or gender identity and expression. Besides advocating for victims of fair housing discrimination, the project also represents tenants facing eviction, ensuring their rights under the Florida Landlord Tenant Act are upheld. During the fiscal year 2024-25, the Fair Housing Project staff served 1,602 clients.

The Public Guardianship Project serves as the legal guardian of indigent residents of Palm Beach, Martin, St. Lucie and Okeechobee Counties who have been declared incapacitated by the Probate Court. The goal of the Public Guardianship Project is to provide direct legal representation to its clients, as well as a full range of professional and supportive services, in order to ensure that their basic needs are met, their quality of life enhanced and that they are provided with all entitlement and financial assistance for which they are eligible. During FY 2024-2025, the Public Guardianship Project provided guardianship services to 217 indigent adjudicated incapacitated elderly who had no family or friends to assist them.

In January 2025, the Florida Civil Legal Aid Association, herein referred to as FCLAA, retained the firm of Colodny Fass. They were retained to advocate for FCLAA pertaining to legislation being put forward by the Florida Banker's Association regarding the distribution of interest on trust accounts, herein referred to as IOTA. IOTA, at all times, has been governed by Chapter 5 of the Rules Regulating the Florida Bar. This Rule was governed and approved by the Florida Supreme Court and was unacceptable to the Banker's Association.

After unsuccessful efforts to change the Supreme Court rule, the Banker's Association, through their lobbyist, (continues on Schedule O)

put forward IOTA legislation that would override the Supreme Court's rule. If the Bankers had been successful with their proposed legislation, FCLAA would have lost over one-hundred million dollars in revenue to represent low-income individuals. Colodny Fass was retained to fight the Bankers efforts in the Florida legislature. This effort was successful, and resulted in legislation that was: fair and acceptable to both sides.
