4a (Code:) (Expenses \$ 1,470,600. including grants of \$) (Revenue \$ 472,312.) Literacy AmeriCorps recruits, trains, and supervises recent college graduates from across the United States who commit a year of service tutoring, mentoring, and teaching throughout Palm Beach County. Their impact includes:

- 432 adult learners received support in reading, English language acquisition, and employability skills.
- 1,143 at-risk youth were coached, tutored, and mentored to promote academic achievement.
- 160 children received tutoring, literacy enrichment, or homework assistance to strengthen their reading skills.

4b (Code:) (Expenses \$ 466,828. including grants of \$ 32,000.) (Revenue \$ 0.) The Glades Family Education Program provides comprehensive literacy instruction to adults and their preschool-aged children living in the rural western communities of Palm Beach County. This two generation model strengthens family literacy and supports longterm educational success.

- A total of 87 adults and 19 preschool children participated in the program.
- An additional 30 children were served through quarterly family literacy nights.
- 82% of adult students who completed both pre and postassessments made significant gains in one or more skill areas, including reading,

The Early Literacy Book Distribution initiative supplies highquality children's books to families participating in the Children's Services Council of Palm Beach County's Healthy Beginnings system of early childhood care. This effort helps build home libraries and promotes early language and literacy development.

- 105,428 books were distributed to families across Palm Beach County through 44 pediatric clinics and 10 Healthy Beginnings program providers, ensuring widespread access for families with young children.
